

## **June 2010 Wadsworth Youth Football Booster Club Meeting Minutes**

### **19:07 Meeting Called to Order**

- 1) Review of First Football Registration**
  - a) A discussion was had on ways to improve this process.**
    - i) Having football Directors stationed at the table to review forms as they are turned in.**
    - ii) Have a brief training session prior to the next registration in order to improve the logging of money transactions.**

- 2) Treasurer's Report**
  - a) 134 participants registered on the first day of sign ups**
  - b) The Treasurer provided a report on the current financial status as well as the current tax status.**
    - i) All are in good standing**
- 3) Director's Report**
  - a) Helmet Ordering**
    - i) Money was provided as a down payment for the order**
    - ii) The manufacturer will provide some additional helmets and a measuring tape to aid in helmet sizing**
    - iii) Sample decals will also be presented for approval**
  - b) Director's will begin meeting on a regular basis in preparation for the season**
  - c) WYF has received permission from Wadsworth City Schools to hand out equipment from the Franklin Elementary School Gymnasium.**
  - d) The League Commissioner of Wadsworth Youth Football League wants to meet with the Directorship regarding the upcoming schedule in an attempt to balance all colors home schedules.**
  - e) May be able to get Art Wright Stadium for one game day,**
    - i) Possibly September 11<sup>th</sup>.**
  - f) The directorship is interested in forming a competition committee to evaluate other leagues.**
  - g) A date needs to be selected for scheduling the 2010 team and individual pictures**
- 4) Cheer Report**
  - a) No Cheer Directors were present**
  - b) A discussion was held on the 2010 mascots**
    - i) Included the potential elimination of mascots**
    - ii) If mascots are to be included in 2010, WYF needs to make sure that the cost of the materials that they receive are covered by the fees**

- iii) If mascots are to be included, the price will remain \$50 as was voted in the by-laws
- 5) **Flag Report**
  - a) **No Flag Directors were present**
- 6) **Executive's Report**
  - a) **Use of the Bird Street complex is going to be heavy over the next couple of years.**
  - b) **Because of potential scheduling conflicts, A and B games may have to be played during the week instead of Saturday's**
  - c) **The field is being prepared for the season.**
    - i) **It has been treated for weeds and will soon be lined**
  - d) **Spectators will not be allowed on the field for any games (i.e. flag or tackle)**
  - e) **Fieldcrest completion**
    - i) **Contract has been signed and construction will soon begin**
    - ii) **An agreement is in place with the City to help with this process**
      - (1) **There were some items on the agreement that were discussed and clarified**
- 7) **Website Update**
  - a) **Would like to have new website on line by 7/1/10**
  - b) **There was a discussion regarding different hosting options for the web site**
  - c) **An email was going to be sent to the Directorship with a link to the prototype web site for review**
- 8) **Volunteering Update**
  - a) **There are some high school students that have expressed an interest in helping during the season**
  - b) **Reviewed some options for memory books that can be sold during the season**
    - i) **Pictures would have to be submitted for inclusion in the books**
    - ii) **WYF has control over content and has flexibility on how the book is constructed.**

  - a) **There was a discussion on different options and venues**
  - b) **Tentative date for this celebration is November 6<sup>th</sup>.**
- 10) **Sponsorship**
  - a) **Going to create a letter campaign for retaining existing sponsors**
  - b) **Looking for bigger sponsors to place on the scoreboard**
  - c) **Discussed "Gladiator Night"**
    - i) **Mike Callow presented the different options for this night and how WYF would benefit from attending this function.**
    - ii) **A motion was made by Michelle Miller and seconded by Tyson Houchin to attend "Gladiator Night" on July 31<sup>st</sup>**
